# Franklin County sheriff's weekly report: Thefts & traffic accidents

Franklin County Sheriff's Office weekly report for Dec. 2 – 9, 2016:

12/2/2016 Sgt. Matt Brann responded to a car vs. deer accident on the Rangeley Road in Phillips.

12/2/2016 Lt. David Rackliffe assisted deputies with a search for drugs in Rangeley.

12/3/2016 Deputy Sandy Burke investigated a theft from Edmunds' Market in Phillips.

12/3/2016 Deputy Andrew Morgan responded to a car vs. deer accident on the Rangeley Road in Madrid.

12/3/2016 Deputy Morgan responded to a 911 hang up on Olde Parkway Road in Kingfield.

12/4/2016 Deputy Morgan investigated a civil issue on the West Road in Chesterville.

The suspect's vehicle appeared to be a gold colored Chrysler with Florida tags. The suspect stated he was staying in the Eustis area. Additional information has enabled Morgan to believe that the alleged suspect is a transient named Michael Shaw, 49, of South Paris. A warrant for his arrest has been issued.

12/5/2016 Sgt. Brann responded to a 911 hang up complaint on the Carthage Road in Carthage. It was determined to be a false alarm.
