### Weekly Report December 14<sup>th</sup> – 21<sup>st</sup> 2018

12/14/2018 1603hrs, Deputy Scovil responded to a report of a single vehicle accident on the Pope Road in Chesterville. No injuries were reported.

12/14/2018 1823hrs, Deputy Morgan responded to a report of a suicidal person on School St. in Kingfield. Investigation revealed that the person involved stated he was not suicidal just misunderstood.

12/15/2018 0046hrs, Deputy Scovil responded to a report of a disturbance on West Kingfield Road in Kingfield. As a result of the investigation, Kim Fish (60) of Kingfield was charged with assault on an officer, refusing to submit to arrest and Terrorizing. He was transported to FMH to be treated for minor injuries.

Hastings near Hammond Lumber and ran over a set of spike mats which started the process of deflating the offenders tires. The offending vehicle ran off the road next to sign works in Farmington, exited his vehicle and attempted to elude on foot but was run down by Deputies Morgan, Scovil and Sgt. Bean. 12/19/2018 1553hrs, Deputy Morgan responded to a report of a two vehicle accident on Mile Hill Road in New Sharon. According to the investigation one vehicle was following a vehicle too closely, the driver of the lead vehicle "check braked" to get the rear vehicle to back off. This occurred twice, on the second time the rear vehicle did not stop and hit the rear of the lead vehicle.
